**ORDINANCE NO. 3497**

**AN ORDINANCE REGARDING THE  
ORGANIZATION OF THE POLICE DEPARTMENT**

**(Harvey Code of Ordinances, Sec. 2-23-010)**

**WHEREAS**, the City of Harvey (“City”) is an Illinois home rule municipal corporation organized and operating pursuant to the Illinois Constitution of 1970; and

**WHEREAS**, Article VII Section 6 of the Illinois Constitution allows home rule municipal corporations to may exercise any power and perform any function pertaining to its government and affairs including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare; and

**WHEREAS**, the City has the authority pursuant to the Illinois Municipal Code to provide police protection for the residents of the City of Harvey; and

**WHEREAS**, the corporate authorities of the City of Harvey have determined it is in the best interests of the City to update the organization of its police department to provide additional positions including two deputy chiefs of police and seven sergeants; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and City Council of the City of Harvey, Cook County, Illinois, as follows:

**Section 1. RECITALS**. The foregoing recitals are incorporated as though fully set forth herein.

**Section 2. AMENDMENT**. Section 2-32-010 of the City of Harvey Code of Ordinances is hereby amended as follows (additions in **bold and underline**; deletions in **~~bold and strikethrough~~**):

2-32-010 There is established an executive department of the municipal government of the city which shall be known as the police department. The department shall consist of the chief of police, ~~the two (2)~~ deputy chiefs of police, four (4) commanders, four (4) lieutenants, seven (7) sergeants and such number of patrolmen, deputy marshals, community service officers and such other nonsworn personnel as may be provided from time to time by the mayor and his/her designee in the annual appropriation ordinance. The department may also be supplemented from time to time by civilian crossing guards to regulate traffic in the vicinity of grade schools during such hours of school days as may be required for that purpose.

**Section 3. SEVERABILITY.** This Ordinance, and its parts, are declared to be severable and any section, paragraph, clause, provision, or portion of this Ordinance that is declared invalid shall not affect the validity of any other provision of this Ordinance, which shall remain in full force and effect.

**Section 4. CONFLICT.** If any part of this Ordinance is found to conflict with any other ordinance, resolution, motion, order, or parts thereof, the most restrictive or highest standard shall prevail.

**Section 5. EFFECTIVE DATE.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.


