ORDINANCE 3498

**AN ORDINANCE AUTHORIZING THE SALE OF SURPLUS PERSONAL
PROPERTY OWNED BY THE CITY OF HARVEY**

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Harvey, Cook County, Illinois, in exercise of its home rule power, as follows:

SECTION 1. Legislative Findings and Intent. The City Council hereby finds that:

A. The City of Harvey is an Illinois home rule municipal corporation that may exercise any power and perform any function pertaining to its governmental affairs; and

B. Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4) authorizes the corporate authorities of the City of Harvey to sell surplus personal property in any manner approved by ordinance; and

C. It is the opinion of a majority of the corporate authorities of the City of Harvey that it is no longer necessary, useful, or in the best interest of the City and its residents to retain ownership of certain personal property (“Property”) hereinafter described in *Exhibit A* hereto; and

D. Disposing of the Property described in Exhibit A in the manner hereinafter set forth is deemed to be the most efficient use of City resources and that disposing of the Property in such a manner is in the public interest; and

E. The corporate authorities of the City of Harvey have determined that the best means of disposing of the Property described in Exhibit A is to authorize the City Administrator to negotiate and execute an agreement for the disposal of the Property; and

F. All net proceeds from the sale of the Property shall be deposited into the City’s General Fund.

SECTION 2. Enactment. Pursuant to its home rule powers and Section 11-76-4 of the Illinois Municipal Code, the Mayor and City Council of the City of Harvey find that the personal property described more particularly in the attached Exhibit A, now owned by the City of Harvey, is no longer necessary or useful to the City and that the best interest of the City will be served by disposing of the personal property. Accordingly, the corporate authorities of the City of Harvey hereby authorize and direct the City Administrator, or his designee, to dispose of the Property under the terms the agreement negotiated by the City Administrator.

All sales shall be on an as-is/where-is basis, with all faults, and with no warranties. Purchasers will be required to waive and release all claims against the City related to the condition or maintenance of the Property.

All proceeds from the sale shall be deposited in the City's General Fund.

SECTION 3. Conflicts. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. Severability. Each provision and application of this ordinance is intended to be considered severable from every other provision and application, so that a finding that any provision or application of this ordinance is unlawful or unenforceable shall not affect the legality and enforcement of every other provision or application to the fullest extent permitted by law.

SECTION 5. Effective Date. This Ordinance shall take effect immediately upon adoption and approval in the manner provided by law.

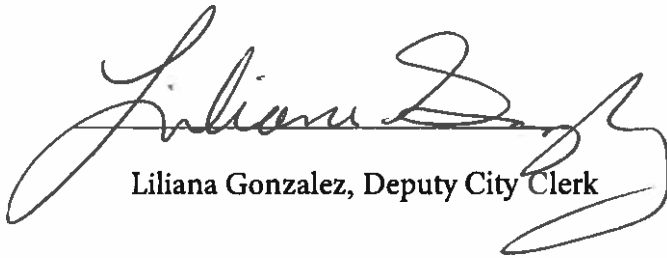
